PREFACE

Gender Responsive Budgeting is a method to mainstream gender into macro level policy. It aims to promote development and empowerment of girls and women ensuring gender equitable distribution of resources, and by contributing to equal opportunities for all. The Gender Budget Statement (GBS) is a tool that has significant relevance in translating the gender commitments of the government into budgetary commitments.

The principle of gender equality is enshrined in the Indian Constitution in its Preamble, and mentioned in the Fundamental Rights, Fundamental Duties as well as Directive Principles of State Policy. The GBS is an effective tool in that regard and is also crucial for monitoring the progress of the state in terms of the goals and targets related to gender under the United Nations' Agenda 2030 of **Sustainable Development Goals (SDGs)**.

The ongoing **COVID-19** pandemic has additionally brought forth multiple challenges and new dimensions of vulnerabilities in addressing the needs of girls and women. Odisha, in keeping up with its constant endeavours towards **inclusive growth**, has taken several proactive steps in ensuring livelihood to women collectives (Women Self Help Groups) by recognizing and promoting their role in the COVID-19 response and subsequent rehabilitation. Gender Budgeting is also a critical step in direction of **better governance** as it ensures more accountability and transparency in the public spending for girls and women as we **'Build Back Better'**.

In efforts to integrate GRB in India's budgeting process, the Government of India introduced the Gender Budget Statement (SBS) in the Union Budget in 2005-6. It constitutes two parts-Part A reflects gender specific schemes having 100 per cent allocation for women and Part B reflects pro women schemes, where at least 30 per cent of the allocation is for women. Following suit, the Government of Odisha developed its first Gender Budget Statement (GBS) in 2012-13, focussing on gender specific schemes and programmes that had 100 per cent budgetary allocation for the welfare of girls and women. In the subsequent years, provision for girls and women under various composite schemes and programmes were also included, under a separate category, if their targeted budgetary allocation was greater than 30 per cent of the

scheme amount. The GBS brings together allocation and expenditure on girls and women across sectors thereby accelerating sustainable and inclusive growth.

Government of Odisha is committed to address the key challenges faced by girls and women in the State including poverty, inequality and violence. Odisha State Policy for Girl children and Women framed in the year 2014, echoes the same sentiment in its guiding principles that insists on equal access for girls and women to rights and entitlements that enable them to lead a life of dignity. We envision that the Gender Budget Statement of 2022-23 will help the respective government departments in identifying, prioritizing, and addressing gender concerns by formulating and implementing future gender policies, provisions and programmes, especially with the **increased vulnerability due to COVID-19** and its short term and long-term impact. And it will also prove useful for UN agencies, civil societies, researchers, and other stakeholders in analysing schemes and programmes related to women in the State. The development of the GBS is not an end in itself but a starting point for a more gender transformative governance and administration.

EXECUTIVE SUMMARY

- ➤ There are 85 schemes and programmes in Gender Specific components and 420 schemes and programmes in Gender Sensitive components in 2022-23 BE.
- The total amount for Gender Budget has gone up from Rs 4854544.65 lakhs in 2021-22 RE to Rs 5684681.24 lakhs in 2022-23 BE.
- ➤ The total outlay on Gender Specific components has increased from Rs. 415775.35 Lakhs in 2021-22 RE to Rs. 607973.01 lakhss in 2022-23 BE as well as Gender Sensitive components has risen from Rs. 4438769.3 Lakhs in 2021-22 RE to Rs. 5076708.23 Lakhs in 2022-23 BE.
- The department of Women and Child Development has the maximum share (48.97%) of the total gender specific budget followed by department of Mission Shakti (33.41%) and Health and Family Welfare Department (9.02%). Likewise, in the Gender Sensitive schemes the department of Panchayati Raj and Drinking Water Department has the highest share (16.60%) followed by Health and Family Welfare Department and department of Works with 14.07% and 10.04% respectively.
- As per 2022-23 BE, the share of gender specific allocation, gender sensitive allocation and total gender budget to state's total expenditure accounts for 4.78%, 39.88% and 44.65% respectively.
- ➤ As per 2022-23 BE, the share of gender specific allocation, gender sensitive allocation and total gender budget allocation to GSDP accounts for 1.12%, 9.35% and 10.47% correspondingly.



CHAPTER I: INTRODUCTION

Gender equality and empowerment of women is the key element of the Sustainable Development Goals (SDGs) Goal 5. It is also part of all other sixteen goals, with many targets specifically recognizing women's and girls' equality and empowerment as both the objective and part of the solution. Around the globe, large proportions of girls and women still face inequality and discrimination on the basis of gender, in turn, giving way to intersectional marginality and multi-dimensional poverty despite significant strides towards gender equality and women empowerment. In governance, Gender Budgeting is a way forward to promote gender equality through the budgeting process, by bringing into focus various government policies that bolster gender equality. Budgeting is a key process that supports the implementation of the Government's operational and financial policies. The gender budget makes it possible for the government to translate their gender commitments to budgetary obligations and to utilize the budget as a tool to influence the lives of girls and women.

The trajectory of the international action for gender equality can be traced back to the Convention on the Elimination of All Forms of Discrimination Against Women (1979), described as the international bill of rights for women. Successive to this was the Beijing Declaration and Platform for Action (1995) adopted by the UN to promulgate a set of principles concerning the equality of men and women. The 21st century, thus saw the concept of gender responsive budgeting gaining widespread recognition across the world. It began getting regarded as an innovative fiscal tool in journey towards gender equality. More than 80 countries have since adopted gender budgeting into their public finance management strategies while adapting the concept to fit their socio-economic and cultural requirements.

The Government of India institutionalized the Gender Budget for the first time in 2005-06 as part of the Union Budget. There onwards, 16 states and 2 UTs have adopted Gender Responsive Budgeting into their fiscal mechanisms. Odisha introduced its first Gender Budget Statements in the FY 2012-13. Although the exercise is aimed at bringing tangible gender outcomes and impacts for girls and women, it goes beyond their wellbeing to contribute to the welfare of the society, at large. When strategically planned, gender responsive fiscal policy can be an effective tool to improve the allocation of existing resources in more gender equitable ways.

THE GENDER BUDGET STATEMENT

The process of Gender Responsive Budgeting does not aim for a separate budget for women but aid the government in effectively streamlining the public expenditure in a gender responsive way. The Gender Budget Statement (GBS) is a key document that can identify the resources to be raised and the expenditure to be made to eliminate gender disparities. Gender budgeting can be carried out through specifically targeted schemes and programmes for girls and women, and through earmarked allocations for women empowerment in universal schemes and programmes.

Government of Odisha had included only 100 per cent gender specific programmes and schemes in the GBS until FY 2015-16. From FY 2016-17 onwards, the GBS was divided into two parts with one part containing only those schemes and programmes which are 100 per cent gender specific and the other part focusing on gender sensitive schemes and programmes with more than 30 per cent but less than 100 per cent provisions for women and girls within a given scheme budget. In this regard, Government of Odisha sees the GBS as a critical strategy in ensuring a **paradigm shift towards gender mainstreaming** across the state machinery.

GENDER RESPONSIVE BUDGETING AMID COVID 19

The second continued year of the COVID-19, its three significant waves of new and everevolving variants of the virus and the subsequent lockdowns and limitation put in place to
handle the pandemic led to several setbacks which have had a differential impact on men and
women. By exacerbating pre-existing economic inequalities within gender groups in the
society, the pandemic has created a disproportionately negative impact on women. The
continued decrement in costs and personnel by the private sector has led to increasing loss of
livelihood, financial independence and mobility for a significant number of rural and urban
women. Even the household level focus on the health and nutritional status of women and girls
has taken a hit, with changed priorities and focus on Covid-19. Crimes against women have
also increased in certain parts and yet are not being reported at the pre-pandemic rate. This
calls for rigorous and concentrated efforts by all actors involved for reversing the loss and
creating positive change for women and girls in the state.

On a positive side, the contribution made by women in combatting Covid related impediments has been significantly noteworthy. Majority of the frontline workers combating the pandemic at the grassroot level are women. Women Self Help Groups (WSHG), ASHA workers, ANMs,

Anganwadi Workers, and other primary caregivers at home have been an integral part of managing the health system delivery in the state. Government of Odisha made a conscious and innovative strategy in this regard, involving women collectives (WSHGs) in the COVID resilience through Mission Shakti Department, which has under its wings about six lakh SHGs and 70 lakh SHG members. The initial peak of the pandemic had these SHG women sewing more than one million masks. Additionally, the SHG women led the social awareness campaigns across the state in spreading messages on COVID appropriate behaviour, contributed to the supply of essential commodities and supplied cooked meals to the vulnerable during lockdown.

With the government prioritizing saving lives and livelihood throughout the pandemic period, Mission Shakti Department, Government of Odisha, has also entered into a partnership with the United Nation World Food Programme (UNWFP) effective till December 2023 to create livelihood opportunities, improve household nutritional security and increase women's participation in decision making. The government had also announced a Rs. 453.5 crore assistance for women SHG as part of a comprehensive COVID 19 package in July 2021.



CHAPTER II: GENDER BUDGETING IN ODISHA

The need for Gender Budgeting arises from the fact that the resource allocation through budgets impact men and women differently. Gender Budget Statement is not a separate budget for women but is a document that helps the Government in highlighting the fiscal allocations made for women and girls under the state's financial plan. At the state level, the Government of Odisha having introduced the **Gender Budget Statement (GBS)** as part of their annual budgeting process in the FY 2012-13, has always been committed to advancing gender equality and ensuring that political will and leadership are channelled towards achieving it.

The Odisha State Policy for Girls and Women, developed by the Department of Women & Child Development and adopted in 2014, focuses on improving the status of girls and women in Odisha in areas including survival; health and nutrition; education; livelihood; asset ownership and decision making, participation and political representation; safety, security and protection; and girls and women with special needs through a life cycle approach. The policy aims to achieve its goals with a mission to create an enabling environment for girls and women that promotes equal opportunities, eliminate discrimination, ensures holistic development and empowerment, and enhances capacities. This year also saw a remarkable development for the women in the state, with the establishment of a separate and dedicated **Department of Mission Shakti**, which focuses specifically on women empowerment through Women Self Help Groups (WSHGs) that will not only actively work towards building economic and livelihood capacities of women from across the state but will also be a welcoming step in formally integrating the WSHG networks in the service delivery of the welfare mechanisms by other departments under a convergence model. This will lead to women led implementation of schemes at the grassroot level and will go a long way in promoting participation and inclusion in the governance machinery.

To strengthen the **Gender Responsive Budgeting**, Government of Odisha has been providing capacity building trainings to various line department and key stakeholders on GRB. Additionally, a **Gender Budget Cell has also been constituted** within several departments for overseeing their respective gender budgeting and mainstreaming related interventions. Furthermore, in an effort to make the budgeting process more transparent and accountable, the Government of Odisha has moved a step further and made the budgetary process digital. Despite such positive outputs, the gender gap that still exists in terms of various development indicators needs targeted and coordinated interventions from all relevant stakeholders. The

Gender Budgeting exercise is thus, a step in that direction to structurally address these gender inequalities.

STAKEHOLDERS OF GENDER BUDGETING

The Gender Budgeting exercise and the Gender Budget statement in Odisha involves and will have an impact on the following stakeholders:

- The women and girls of Odisha constituting about 49.4% of the population.
- Department of Women and Child Development (the nodal agency at the State level)
- Department of Finance and Planning & Convergence Department
- Respective Line Departments of the Govt. of Odisha
- UN Agencies and civil societies
- Academia, researchers and other knowledge management groups
- Elected legislative representatives
- Media
- Business and Corporate Sector

SCOPE OF THE GENDER BUDGET STATEMENT

The Gender Budget Statement provides critical information on fiscal allocation of the state from a gender perspective by reviewing the schemes and programmes of various departments from a gender lens. As a tool that promotes gender equality, it helps in identifying the **opportunities and scope for further intervention** by the Govt, as it highlights the actual figures of allocation, revision and use of the funds by the department for last 3 years and thus enables them to **find gaps in implementation**. Furthermore, the document will specifically aid in:

- 1. **Identifying** the government schemes and programmes from across departments, which helps in promoting the development of women for the last three fiscal years.
- 2. Analysing the percentage of Administrative and Programme Expenditure of various schemes and programmes included in the statement. This can further help in **developing targeted fiscal and implementation strategies** for gender mainstreaming.
- 3. Examining the budgetary allocation for gender in relation to total Expenditure of the state as well as Gross State Domestic Product.

METHODOLOGY USED

The Gender Budget Statement of Odisha has been prepared by analysing the 45 demands for grant of the various departments under the government for expenditure earmarked for women and girls. Further, the schemes and programmes thus identified are categorized into **gender specific** and **gender sensitive** while mapping the expenditure details including **Administrative Expenditure** and **Programme Expenditure**.

The schemes and programmes are also further bifurcated in terms of the **source of funding** under the following heads:


- a. State Sector Schemes
- b. Central Sector Schemes
- c. Centrally Sponsored Schemes
- d. Establishment Operation and Management (EOM) Expenditure
- e. Disaster Relief Funds

In line with the Union Gender Budget Statement, Odisha also has segregated the gender budget into the following two parts:

The timeframe for the analysis of this GBS includes the **Actual Expenditure** for the FY 2020-21, the **Revised Estimates** for the FY 2021-22 and the **Budget Estimates** for the FY 2022-23.

PROCESS OF GENDER BUDGETING IN ODISHA



3.1 INTRODUCTION

Gender Budgeting is an attempt to supports the implementation of the Government's operational and financial policies to promote gender equality through the budgeting process, by bringing into focus various public schemes and programmes that bolster gender equality. The Gender Budget Statement (GBS) is a tool that has significant relevance in translating the gender commitments of the government into budgetary commitments and to utilize the budget as a tool to influence the lives of girls and women. Accordingly, the GBS 2022-23 has been formulated based on the information received from the respective departments of the state, generated in their demand draft and their allocation of expenditure.

This section illustrates the details of the budgetary allocations for women across some key indicators and variables. The findings on gender centric numbers of departments, department-wise schemes and programmes, Share of Gender budget to Total State Expenditure and Gross State Domestic Product (GSDP) etc are explained in this section. The detailed account on the budgetary allocations for women and girls are divided into three broad sections, such as - Cumulative Gender Budget, ii. PART A: Gender Specific (100%) Analysis, and iii. PART B: Gender Sensitive (>30%) Analysis.

3.2 CUMULATIVE GENDER BUDGET

A detailed analysis of the cumulative allocation to both gender specific and sensitive programmes, across sectors, departments and expenditure type are taken in this part. **Table 3.1** shows that total budgetary amount for Gender Budget for 2022-23 BE is Rs. 5684681.24lakhs, out of which the gender specific components include Rs. 607973.01 lakhs and gender sensitive elements accounts for Rs. 5076708.23 lakhs which is a substantial portion of the total state budget outlay.

Table 3.2 illustrates the share of gender specific, gender sensitive and the total gender budget to state's total expenditure and GSDP for the three financial years. It is found that for the year

2020-23 BE the share of gender specific budget to state's total expenditure comprise of 4.78% whereas, gender sensitive budget consists of 39.88% and thereby as whole, the share of total gender budget to total expenditure accounts for 44.65% as per the budget estimates 2022-23. Similarly, the share of gender specific and sensitive components to GSDP contain 1.12% and 9.35% respectively having 10.47% share of total gender budget to GSDP according to 2022-23 BE.

3.2: PART A: GENDER SPECIFIC BUDGET

Part A constitutes the allocations made to the schemes and programmes which are gender specific where 100% allocation is made towards the welfare and development of women and girls of Odisha. Accordingly, the total allocation of Rs 607973.01lakhs made for gender specific components are divided across 15 departments and 85 schemes and programmes as per 2022-23 BE.

Figure 3.1 illustrates the top 10 departments based on the distribution of Schemes and Programmes in descending order as per 2022-23 BE. It is found that the department of Women and Child Development has the maximum numbers of schemes (34) next to which Health and Family Welfare department (16).





Figure 3.2: Distribution of Schemes and Programmes across Types and Sources of Funds

Further, **Figure 3.2** describes the distribution of Schemes and Programmes across Types and Sources of Funds in 2022-23 BE. As per the estimates, the State Sector Schemes (CS) accounts for the maximum number of schemes and programmes (37), next to which the Centrally Sponsored Schemes (CSS) includes a major number (32). Thereafter, the Establishment, Operations and Management (EOM) comes up with 13 numbers, and Disaster Risk Management Fund (DRMF) with 1 numbers of schemes and programmes.

Figure 3.1: Distribution of Schemes and Programmes across Departments (Top 10) in 2022-23 BE


Further, **Table 3.3** depicts the distribution of gender specific allocation across departments. The department of Women and Child Development has the highest allocations of Rs 297722.89lakhs, followed by department of Mission Shakti with Rs 203101.32lakhs and Health and Family Welfare department with Rs 54810.74lakhs.

Additionally, **Figure 3.3** shows the shares of department-wise distribution of gender specific allocation where top 10 departments are displayed. It is clearly depicted that the highest share of allocation is estimated by the Department of Women and Child Development (48.97%) followed by the department of Mission Shakti (33.41%) and Health and Family Welfare department (9.02%).

Further, mapping of total allocation of 100% gender specific schemes across type of expenditure and the sources of funding has been represented in the **Table 3.4**. As per 2022-23 BE, Pragramme Expenditure (PE) contributes the highest amount with Rs 600883.05lakhs which includes Central Sector Schemes (CS), Centrally Sponsored Schemes (CSS) and State Sector Schemes (SSS) which combinedly accounts for 98.83% share to total gender specific allocation. The Establishment, Operations and Maintenance (EOM) falls under Administrative Expenditure (AE) of the state that have been allocated with Rs 6589.96lakhs which is 1.08% to total gender specific allocation.

Figure 3.4 illustrates the share of total allocation of gender specific schemes across types of expenditure as per 2022-23 BE. The Programme Expenditure has the lion chunk of the total allocation i.e., 98.83%, while Administrative Expenditure and Disaster Risk Management Fund have the shares of 1.08% and 0.08% respectively.

Figure 3.4: Share of Total Allocation of Gender Specific Schemes and Programmes across Types of Expenditure (2022-23 BE)





Figure 3.5 represents the distribution of total allocation of gender specific schemes across source of funds as per the budget estimates 2022-23. The Centrally Sponsored Schemes (CSS) has the highest share of 64.61%, next to which the State Sector Schemes (SSS) has 33.44% of total gender specific budget allocation. While, the Establishment, Operations and Management (EOM) shares 1.08%, and Central Sector Schemes (CS) and Disaster Risk Management Fund (DRMF) share 0.79% and 0.08% correspondingly.

Figure 3.5: Distribution of Total Allocation of Gender Specific Schemes across Source of Funds (2022-23 BE)




3.3: PART B: GENDER SENSITIVE BUDGET

Part B constitutes the allocations made to the schemes and programmes which are gender sensitive where more than 30% but less than 100% allocation is made towards the welfare and development of women and girls of Odisha. Accordingly, the total allocation of Rs 5076708.23 lakhs made for gender sensitive components are divided across 35 departments and 420 schemes and programmes as per 2022-23 BE.


Figure 3.6 illustrates the top 10 departments based on the distribution of Schemes and Programmes in descending order as per 2022-23 BE. It is found that the Department of Agriculture and Farmers' Empowerment (A&FE) has the maximum numbers of schemes (38) followed by Women and Child Development (WCD) have 36 numbers of schemes and programmes each and, Health and Family Welfare with 34 number of schemes and programmes.

Further, **Figure 3.7** describes the distribution of Schemes and Programmes across types and sources of funds in 2022-23 BE. As per the estimates, the State Sector Schemes (SSS) accounts for the maximum number of schemes and programmes (273), next to which the Centrally Sponsored Schemes (CSS) with 74 numbers. Thereafter, the Establishment, Operations and Management (EOM) comes up with 59 numbers, Central Sector Schemes (CS) with 8, Disaster Management Fund (DRMF) with 4 (3 SDRMF and 2 NDRMF) and finally transfer from State Finance Commission (SFC) with 2 numbers of schemes and programmes.

Further, **Table 3.5** depicts the distribution of gender specific allocation across departments. The Panchayati Raj and Drinking Water Department has the highest allocation with Rs. 842587.92 lakhs, followed by Department of Health and Family Welfare with Rs. 714124.34 lakhs, and School and Works Department with Rs 509596.42lakhs.



Additionally, **Figure 3.8** shows the shares of department-wise distribution of gender sensitive allocation where top 10 departments are displayed. It is clearly depicted that the highest share of allocation is estimated by the Panchayati Raj and Drinking Water Department (16.60%) of total gender sensitive budget followed by Department of Health and Family Welfare with 14.07% and Work Department with 10.04%.

Further, mapping of total allocation of gender sensitive schemes across type of expenditure and the sources of funding has been represented in the **Table 3.6**. As per 2022-23 BE, Programme Expenditure (PE) contributes the highest amount with Rs **4624069.61**lakhs which includes Central Sector Schemes (CS), Centrally Sponsored Schemes (CSS) and State Sector Schemes (SSS) which combinedly accounts for 91.08% share to total gender sensitive allocation. The Establishment, Operations and Maintenance (EOM) falls under Administrative Expenditure

(AE) of the state that have been allocated with Rs 153852.59lakhs which is 3.03% to total gender specific allocation.

Figure 3.9 illustrates the share of total allocation of gender sensitive schemes across types of expenditure as per 2022-23 BE. The Programme Expenditure has the lion chunk of the total allocation i.e., 91.08%, while Disaster Risk Management Fund, Administrative Expenditure and transfer from State Finance Commission have their respective shares of 5.21%, 3.03% and 0.68%.

Figure 3.9: Share of Total Allocation of Gender Sensitive Schemes and Programmes across Types of Expenditure (2022-23 BE)





Figure 3.10 represents the distribution of total allocation of gender specific schemes across source of funds as per the budget estimates 2022-23. The State Sector Schemes (SSS) has the highest share of 52.47%, next to which the Centrally Sponsored Schemes (CSS) and Disaster Risk Management Fund (DRMF) with 38.40% and 5.21% correspondingly. Furthermore, the Establishment, Operations and Management has 3.03% and transfer from State Finance Commission has 0.68%.

The Government of Odisha has been focusing on various women-centric initiatives through its budgetary provisions. The allocations in 2022-23 BE are more for gender specific schemes and programmes like Supplementary Nutrition Programme (Sakshyam Anganwadi and POSHAN 2.0) with Rs.111319.6 lakhs, Indira Gandhi National Widow Pension Scheme with Rs. 31895.06 lakhs, State support to ICDS Rs. 31469.79 lakhs and Conditional Cash Transfer for Pregnant Women (MAMATA) with RS. 24740.18 lakhs. Likewise, for gender sensitive component, the major initiatives are Biju Swasthya Kalyana Yojana (Rs. 266438.45 Lakhs) and Mukhya Mantri Swasthya Seva Mission (Rs. 233514.72 Lakhs), Such proactive initiatives

through higher allocation of public expenditures on women-centric initiatives would surely reinforce the welfare and development of women in the state.
