Subject: Gender Analysis of select schemes of Ministries/Departments for reporting allocation in the Gender Budget Statement (GBS) – Statement 13 of the Expenditure Profile for FY 2025-26 — Reg.

Para 13.6 in the Budget Circular 2025-26 issued by the Department of Economic Affairs (DEA) *vide* O.M. dated 17.09.2024 mandates all the Ministries and Departments to specifically report allocations for women and girls in the Gender Budget Statement (Statement 13 of the Expenditure Profile) in a prescribed format. Ministry of Women and Child Development (MWCD) has been providing training and support for building capacity of central Ministries/Departments about the process of gender budgeting.

- 2. In this regard, it is informed that Gender Budget Division, MWCD has undertaken analysis of major schemes of selected Ministries/Departments from a gender lens to facilitate reporting of financial allocations in the Gender Budget Statements for financial year 2025-26. This analysis has been shared with Ministries/Departments *vide* MWCD O.M. dated 03.12.2024. It comes out that some of the schemes have a good potential for inclusion in the Gender Budget Statement for financial year 2025-26.
- 3. Higher Gender Budget is expected to accelerate the process of women-led development and increase overall welfare of women. Accordingly, it is requested that Budget/Programme/Nodal Divisions may be advised to undertake requisite steps for preparing the Gender Budget Statement as part of budget preparation for FY 2025-26.
