Subject: Invitation of proposals for organizing Training Programmes/ Workshops on Gender Budgeting under Mission Shakti: Gender Budgeting Scheme of the Ministry of Women and Child Development during FY 2025-26 - Regarding.

The Ministry of Women and Child Development has been providing financial assistance in the form of 100% grants-in-aid to organize training programmes and workshops on Gender Budgeting at the Central and State/UT levels under the Gender Budgeting Scheme. - 3. The implementing agencies other than the State/UT Departments applying under the scheme must have adequate experience in conducting the training on gender budgeting along with requisite infrastructure facilities, resources, and personnel. Preference will be given to the National and State level Training Institutes and the Institutes of Eminence having adequate infrastructure facilities and in-house resources and personnel for undertaking gender budgeting training.
- 4. Proposal for organizing maximum of three training programmes under the Gender Budgeting Scheme during FY 2025-26 may be submitted online using the URL https://missionshakti.wcd.gov.in/gender-budgeting/gb_scheme latest by 31st October 2025.
